

TRUSTEE'S NOTICE OF SALE

Reference is made to that certain trust deed made by NELSON D DEJESUS, A SINGLE PERSON as grantor, to CHICAGO TITLE INSURANCE CO as trustee, in favor of WELLS FARGO HOME MORTGAGE, INC. as beneficiary, dated June 11, 2001, recorded June 21, 2001, in the mortgage records of Multnomah County, Oregon, as Document No. 2001-093003, covering the following described real property situated in said county and state, to wit:

The default for which foreclosure is made is grantors' failure to pay when due the following sums: monthly payments in the total amount of \$17,786.60 beginning March 1, 2015 through July 15, 2016; plus an unpaid advance balance of \$1,179.00; plus other fees and costs in the amount of \$218.80; together with title expense, costs, trustee's fees and attorney's fees incurred herein by reason of said default; any further sums advanced by the beneficiary for the protection of the above described real property and its interest therein; and prepayment penalties/premiums, if applicable.

By reason of said default, the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to wit: \$127,257.95 with interest thereon at the rate of 5.00000 percent per annum beginning February 1, 2015; plus escrow advances of \$4,093.37; plus other fees and costs in the amount of \$14,615.40; together with title expense, costs, trustee's fees and attorney's fees incurred herein by reason of said default; any further sums advanced by the beneficiary for the protection of the above described property and its interest therein; and prepayment penalties/premiums, if applicable.

WHEREFORE, notice is hereby given that the undersigned trustee will on November 22, 2016, at the hour of 11:00 AM, in accord with the standard of time established by ORS 187.110, at Multnomah County Courthouse Front Entrance, 1021 SW 4th Avenue, Portland, OR 97204, in the City of Portland, County of Multnomah, State of Oregon, sell at public auction to the highest bidder for cash the interest in the real property described above, which the grantor had or had power to convey at the time of the execution by grantor of the trust deed together with any interest which the grantor or grantor's successors in interest acquired after the execution of the trust deed, to satisfy the foregoing obligations thereby secured and the costs and expenses of the sale, including reasonable charges by the trustee. Notice is further given that any person named in ORS 86.778 has the right, at any time that is not later than five days before the date last set for the sale, to have this foreclosure proceeding dismissed and the trust deed reinstated by payment to the beneficiary of the entire amount then due (other than such portion of the principle as would not then be due had no default occurred) and by curing any other default complained of herein that is capable of being cured by tendering the performance required under the obligation or trust deed, and in addition to paying those sums or tendering the performance necessary to cure the default, by paying all costs and expenses actually incurred in enforcing the obligation and trust deed, together with trustee and attorney fees not exceeding the amounts provided by ORS 86.778.

Without limiting the trustee's disclaimer of representations or warranties, Oregon law requires the trustee to state in this notice that some residential property sold at a trustee's sale may have been used in manufacturing methamphetamines, the chemical components of which are known to be toxic.
